# RISK MANAGEMENT AT WORLD HERITAGE SITES

The National Heritage Institute invites you to an international conference focusing on both Czech and foreign experience with world heritage sites management. Its primary aim is to discuss how to address risk factors that have been observed during periodic, annual or *ad hoc* monitoring. The conference is being organised in cooperation with the National Committee of ICOMOS and the National Technical Museum, under the auspices of the Czech Commission for UNESCO and with the support of the Ministry of Culture of the Czech Republic.

The conference is held at the opportunity of the 70<sup>th</sup> anniversary of UNESCO and strives to bring attention to the wide scope of action of this organisation in world heritage protection. Its aim is not only to define the risk factors of world heritage sites management in the Czech Republic, but also to show examples of how they can be avoided, how successful we can be in reducing them and of what measures were taken to eliminate them. Moreover, the conference will present the results of the second cycle of periodic world heritage monitoring in Europe and North America, which also includes the Czech Republic from the viewpoint of world heritage. Aims of the conference:

- Strengthening implementation of the Convention Concerning the Protection of the World Cultural and Natural Heritage as regards comprehensive provision of experts for handling such property
- Exchanging experience with and improving knowledge of mitigation of risk factors influencing the widest array of world heritage sites
- Supporting international cooperation and sharing of knowledge and experience with management and administration of world heritage sites
- Networking of individuals responsible for specialised care, management and administration of Czech cultural sites inscribed on the World Heritage List
- Thematically rich discussion about management and monitoring of cultural heritage and the roles of various components of society in this process

On 19 November, 2015, the conference will host speakers from Slovakia, Poland, Hungary and the Czech Republic; interpreting from English into Czech will be available.
